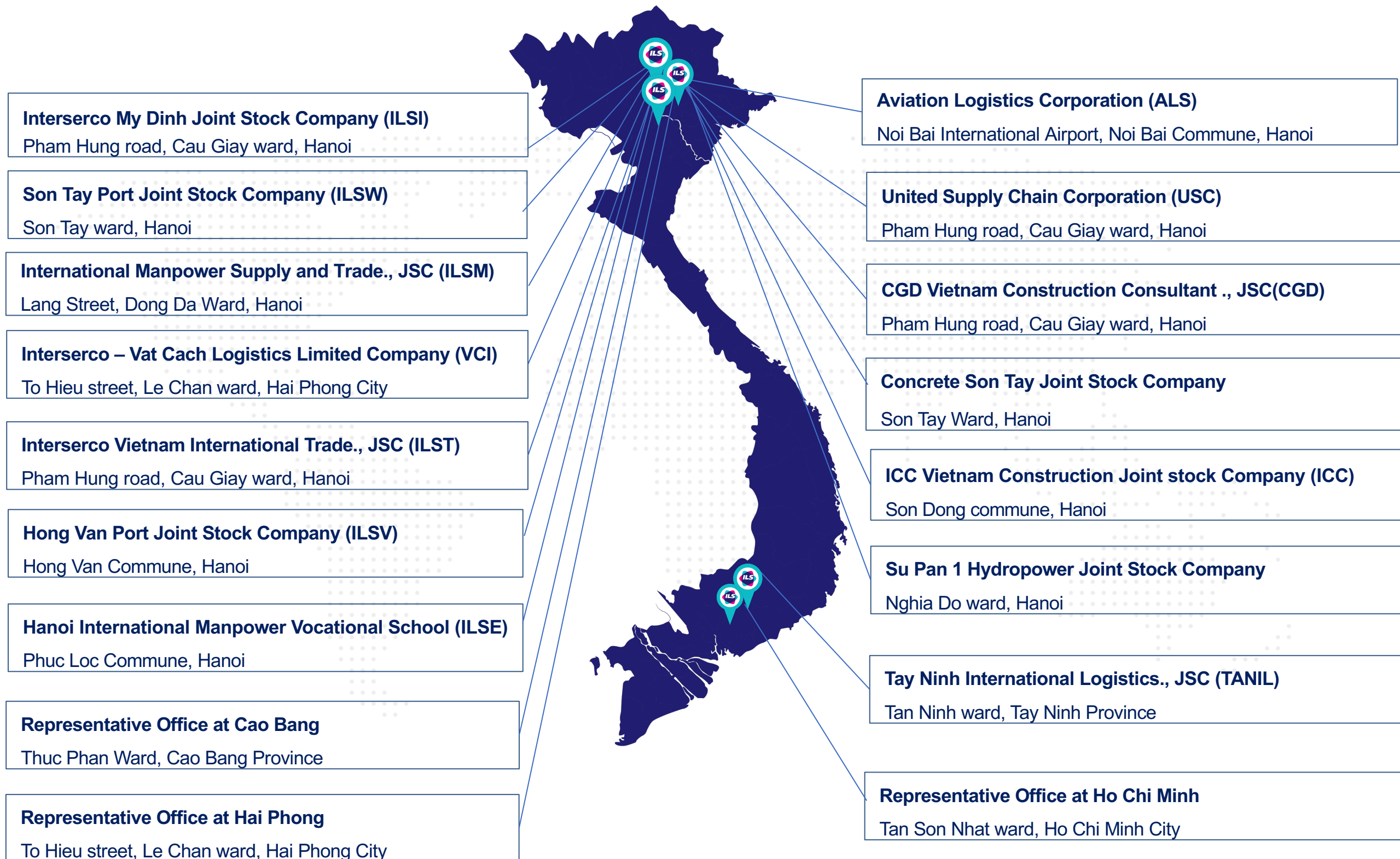

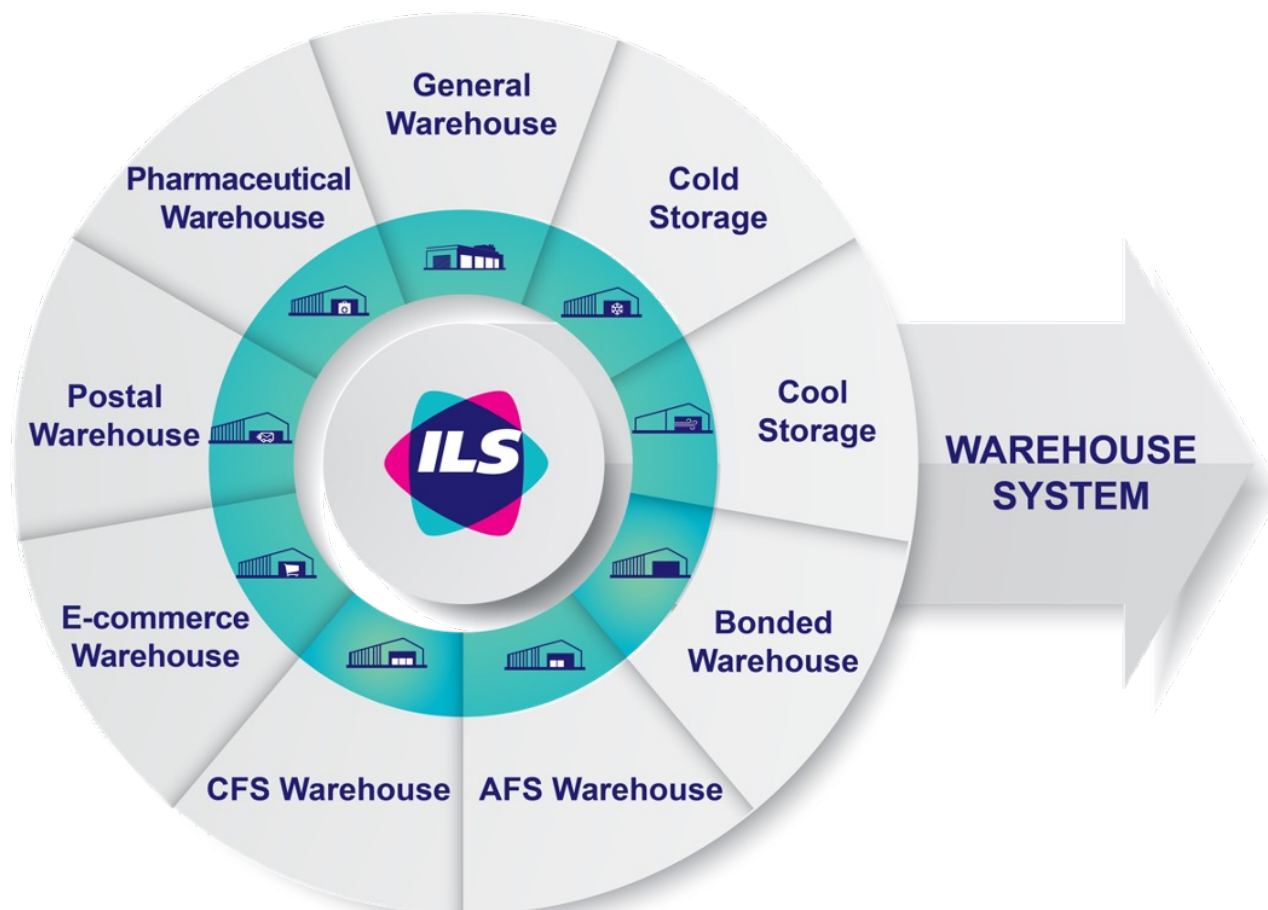
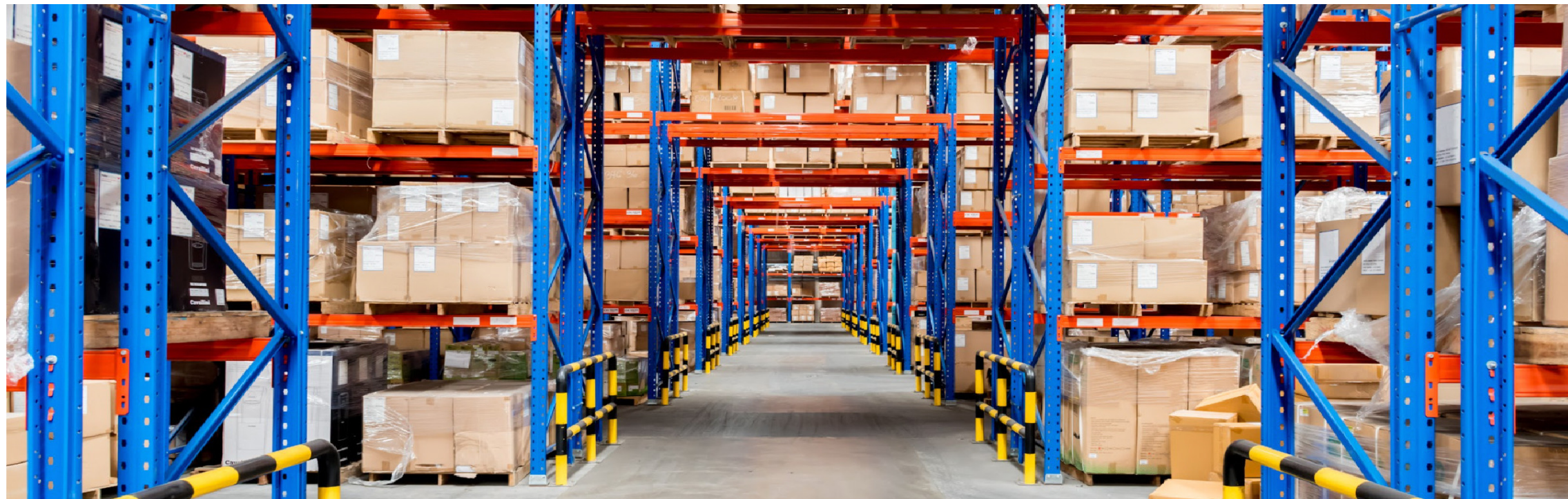
## 1.1 WAREHOUSE AND YARD SYSTEMS

ILS owns a system of warehouses and yards over 150,000m<sup>2</sup>, concentrated in convenient gateway locations, easily rotating connections to distribution locations in and out of Hanoi.

## 1.2 CUSTOMS AGENT

ILS has closed relationship with customs and inter-sectoral agencies in handling international import and export goods. LS is committed to providing customers services of customs declaration, and customs clearance at the most economical cost.

ILS is Customs agent for many big customers in Industrial Parks and Export Processing Zones...such as Canon, ZF, Vinfast, Abbot, etc/ (for import-export goods);

ILS provides Customs agent service for goods subject to a special category according to Decision 38/TTCP for customers Thien Linh, Klever Fruit, etc.

### Providing post-customs clearance services:

- Reporting on Export-Import Inventory for Export Processing Enterprises (EPE).
- Liquidating a processing contract; liquidating tax-exempt machinery and raw materials classified as fixed assets.
- Specialized license consulting.
- Price consulting, post-clearance inspections.
- Tax refunds, tax finalization and other services including : Certificate of Origin (C/O), HS Code, certificate in regulations/standard and quarantine.

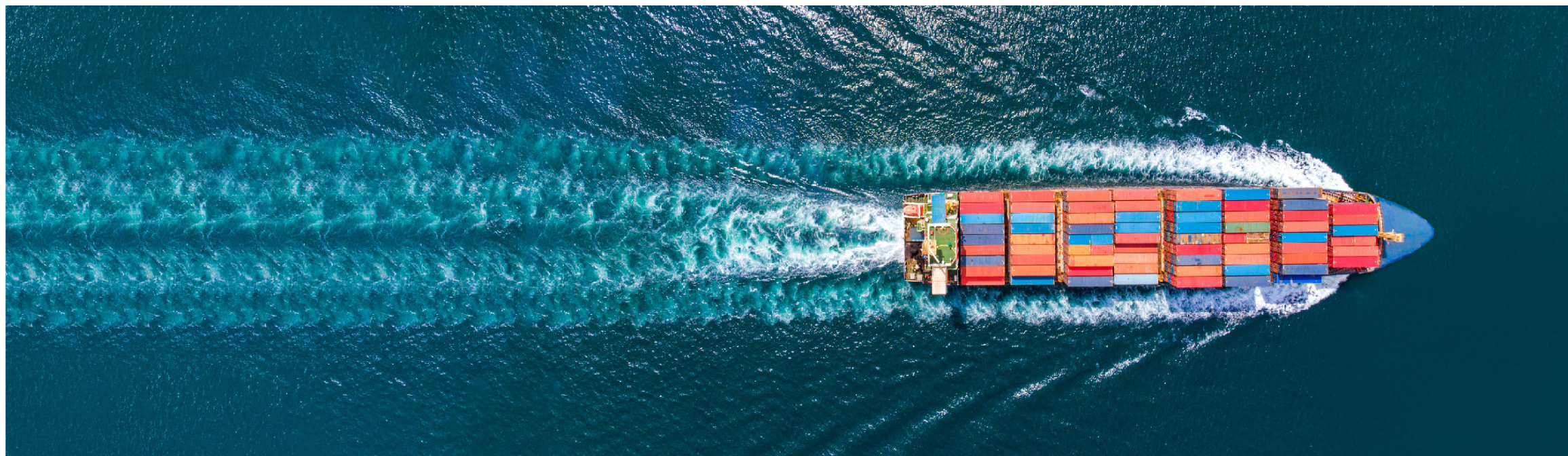

### 1.5 INLAND WATERWAY TRANSPORT SERVICE

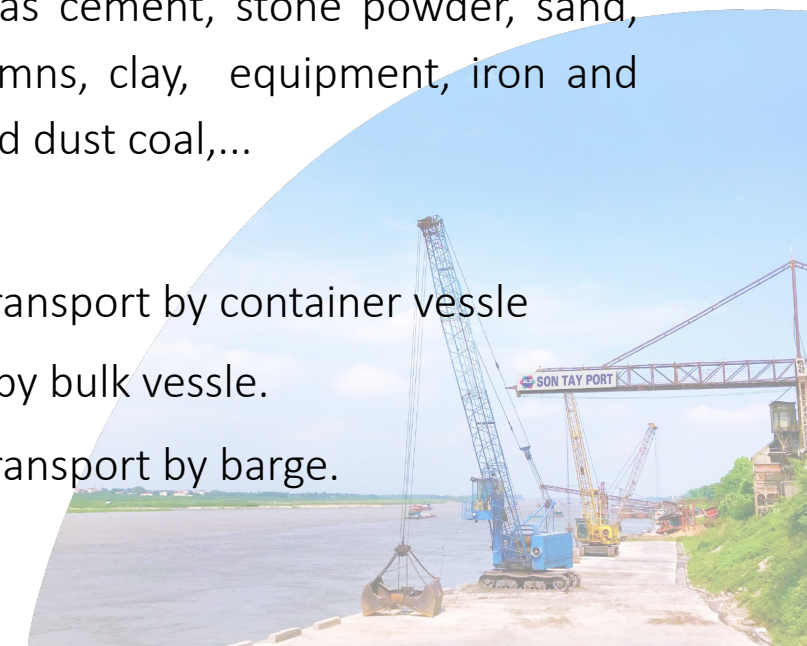
ILS manages and operates 02 river ports:

- **Hong Van Port:** Area of 10 hectares, length of 500m of water surface with standard warehousing system and modern loading and unloading equipment, is a point of inland customs clearance for goods that are containers from Hai Phong seaports, Quang Ninh to Hanoi and vice versa.
- **Son Tay Port:** An area of 5ha is a focal place for gathering and transshipment of goods as construction materials for the needs of expansion and urban construction west of Hanoi, connecting with Viet Tri port on the Hai Phong - Hanoi - Viet Tri- Lao Cai corridor.

ILS provides inland waterway transport services with barges and small vessels that are suitable for types of goods such as agricultural products, fruits or heavy-volume cargo such as cement, stone powder, sand, brick, concrete columns, clay, equipment, iron and steel, manganese and dust coal,...

#### Services:

- Domestic cargo transport by container vessel
- Domestic freight by bulk vessel.
- Domestic cargo transport by barge.

## 1.6 AIRFREIGHT FORWARDING

With a dynamic agency system in the world, ILS provides high-quality air freight forwarding and transportation services from Vietnam to international airports and vice versa.

Especially, we have signed contracts with major airlines to carry out transportation processes for factories from Hanoi, Thai Nguyen, Bac Ninh, Bac Giang, Hai Phong... to cities in America, Europe, Asia & Australia. Cargo can be completed procedures at the Off-Airport Cargo Terminal at Bac Ninh IP, Thai Nguyen IP to Noi Bai Airport that will be safer, faster, more convenient and more cost- saving than normal way.

- Collecting retail goods, whole containers, and whole wagons. Transport goods from Warehouse to Warehouse, Station to Station, Warehouse to Station, Station to Warehouse
- Transportation of imports, transit goods: Fertilizer on HaKou- Lao Cai- Hai Phong route.
- Bulk cargo: Apatit ore, fertilizer bags of Lao Cai – Viet Tri – Hai Phong line, transporting coal and sulfur in the opposite direction.

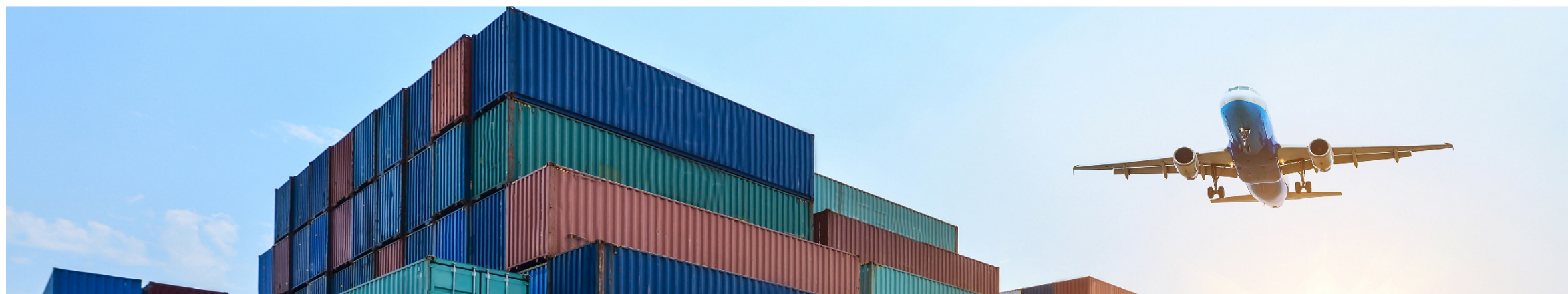
